

**MEMORENDUM OF UNDERSTANDING
FOR EDUCATIONAL COOPERATION
BETWEEN
PANDIT SUNDARLAL SHARMA (OPEN)
UNIVERSITY CHHATTISGARH, BILASPUR
AND
RAJIV GANDHI GOVT. ARTS & COMMERCE
COLLEGE, LORMI, DIST. MUNGELI, C.G.**

1. Parties

The parties to this MEMORENDUM OF UNDERSTANDING are

- Pandit Sundarlal Sharma (Open) University Chhattisgarh, Bilaspur hereafter referred to as "PSSOU."
- Rajiv Gandhi Govt. Arts & Commerce College Lormi, Dist. Mungeli, C.G. (RGGC)

2. Purpose

2.1 The purpose of this MEMORENDUM OF UNDERSTANDING is to promote international agreement, scholarly collaboration, cultural interaction and friendship by supporting educational, professional and cultural activities among faculty and students of the two institutions. Accordingly, the areas of cooperation will include, subject to mutual consent, any programme offered at their institution as felt desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two institution.

Specific areas of cooperation between the two institutions, subject to the availability of funds and the approval of RGGC and PSSOU, include, but not limited to the following:

- (a) Exchange of faculty members;
- (b) Joint research activities;
- (c) Participation in seminars and academic meetings;
- (d) Developing and executing special academic programmes; and
- (e) Joint consultancies.
- (f) Organizing joint conferences/seminars/workshops
- (g) Exchange of academic materials and other information.

- (h) Exchange of resources for academic purpose.
- 2.2 A Memorandum of Understanding (MOU's) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time, but require the signatures of both Registrar of the university and Principal of the college.
- 2.3 The purpose of this MEMORENDUM OF UNDERSTANDING is to outline an academic and management framework between the two parties, designed to promote internationalization at both institutions. The parties do not intend to be legally bound to each other, and this MEMORENDUM OF UNDERSTANDING does not impose legal obligations on either party.

3. Notices

Every notice, request or any other communication required or permitted to be given pursuant to this Memorandum of Understanding shall be in writing and delivered personally or sent by registered or certified post or via air mail or via courier or facsimile or by e-mail (which shall be acknowledged by the other Party) to the Parties at their address and facsimile number as stated below:

5. Duration of MEMORENDUM OF UNDERSTANDING

- 5.1 This MEMORENDUM OF UNDERSTANDING will be effective upon signature by each institution Registrar/ Principal (or an expressly

designated delegate) for a period of three years, at which time it will be reviewed for possible renewal for another three-year period.

5.2 Either party may, with sixty days written notice, terminate the MEMORENDUM OF UNDERSTANDING in advance of its normal expiration or request the renegotiation of its conditions.

6. Other Terms

6.1 Any dispute or difference arisen out of this MEMORENDUM OF UNDERSTANDING shall be resolved through amicable settlement.

6.2 Each party shall co-indemnify and hold each party harmless for any and all costs or expenses associated with damages or claims arising out of activities commenced under this MEMORENDUM OF UNDERSTANDING, or any act or omission of the party, its employees or others acting on its behalf while undertaking any aspect of these cooperative activities.

6.3 This MEMORENDUM OF UNDERSTANDING is in two originals, and both parties shall hold one original copy.




