### **Report on the Financial Statements**

We have audited the accompanying financial statements of **Pandit Sundarlal Sharma Open University, Bilaspur, Chhattisgarh** which comprise the Balance sheet as at 31st March 2018 and the Statement of Profit for the year then ended.
