E- 1.1: Four Year Undergraduate Programme (FYUP) (Under Section 27(1) of Chhattisgarh Act No. 26/2004)

(With Choice Based Credit System and Multiple Entry and Exit Options as per NEP 2020)

1. Short Title and Commencement

- **1.1** This Ordinance shall be called "Ordinance for Four Year (Eight Semesters) Undergraduate Programme (FYUP)".
- **1.2** It shall apply to undergraduate programmes B.A., B.Sc., B.Com., BCA, BBA under semester system, and any other undergraduate programme as notified by the University from time to time.

2. Definition and keywords

In this Ordinance, unless the context otherwise requires:

- **2.1 "Choice Based Credit System" (CBCS)** means a programme that provides choice for learners to select from the prescribed courses (Core, Elective, Ability Enhancement courses, etc.) as approved by the University from time to time.
- **2.2 "Undergraduate Curriculum Framework"** means a choice based credit framework of curriculum for undergraduate programmes.
- **2.3 "Course"** means a plan of study in a particular subject through different modes of delivery and is a component of a programme as detailed out in the respective programme structure.
- **2.4** "Letter Grade" means an index of the performance of learners in a course and is denoted by letters O, A+, A, B+, B, C, P, F and Ab.
- 2.5 "Credit" means a unit by which the course is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one-hour teaching (lecture, seminar or tutorial) per week or two hours of practical work/field work/project/out-of-class activity etc. per week. One credit involves a minimum of 30 hours of teaching (learning) and practical work/field work/project/out-of-class activity etc. in a semester. The number of credits for each course shall be defined in the respective examination scheme.
- **2.6 "Grade Point"** means points assigned to each course credit in accordance with the letter grade earned in the courses.

- **2.7 "Credit Point"** means the product of grade point and number of credits for a course.
- 2.8 "Semester Grade Point Average (SGPA)" means the ratio of total credit points secured by a student in various courses registered in a semester and the total credits of all courses during the semester. It measures the performance of a study. It shall be expressed up to two decimal places and shall be calculated as per Appendix III of this ordinance.
- **2.9 "Cumulative Grade Point Average (CGPA)"** means a measure of overall cumulative performance of a student in all semesters. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all semesters. It shall be expressed up to two decimal places and shall be calculated as per **Appendix III** of this ordinance.
- **2.10 "Semester"** means a half year term that normally include an academic session spread over minimum 15 weeks of teaching days. The odd semesters may normally be scheduled from July to December and even semesters from January to June.
- 2.11 "Grade Card" means a mark sheet based on the grade earned. Grade certificate shall be issued to the registered learner after every semester. The grade certificate will contain the course details (code, title, number of credits, grade secured etc.) along with SGPA of the semester and CGPA earned till date semester. The final semester grade certificate shall also reflect the cumulative total of marks obtained by the learners in all semesters out of maximum marks allocated for which the grades of the programme were evaluated. However, the final result will be based on the grade / CGPA.
- **2.12 "SWAYAM" (Study Webs of Active-Learning for Young Aspiring Minds)** means an InformationTechnologyplatformdevelopedandmadefunctionalbytheGovernment of India in the Ministry of Education, for the purpose of offering online learning courses/Massive Open Online Course (MOOC).
- **2.13 "Academic Bank of Credit (ABC)"** means digital storehouse which contains/stores the academic credit earned by an individual student from various recognized HEIs so that the degree from an HEI can be awarded taking into account the credits earned.

- **2.14 "Transcript"** means a certificate issued to all enrolled learners in a programme after successful completion of the programme. It contains the SGPA of all semesters and the CGPA.
- **2.15 "Summer term"** means a duration of two weeks coinciding with summer vacation for Internship/apprenticeship/work-based vocational education and training which can be carried out especially by learners who wish to exit after two semesters or four semesters of study.
- **2.16 "Credit earned"** means the credits associated with a course which has been cleared by the learners.
- **2.17 "NHEQF Level"** means National Higher Education Qualification Framework (NHEQF) level, an instrument for the classification of qualifications according to a set of criteria for specified levels of learning achieved.
- **2.18 "Major discipline"** means the discipline or learners of main focus opted by the learner and the degree will be awarded in that discipline. Learners should secure the prescribed number of credits (about 50% of total credits) through core courses in the major discipline.
- **2.19 "Minor discipline"** means the discipline student opts to gain a broader understanding beyond the major discipline.

3. Duration:

- 3.1 The duration of the UG programme is 4 years or 8 semesters. Learners who desire to undergo a 3-year UG Programme will be allowed to exit after successful completion of the third year. If a learner wants to leave after the successful completion of the first and second year, he/she shall be awarded a UG Certificate and UG Diploma, respectively. The credit requirements of various levels of programme of study along with stage of exit shall be as per **Appendix-I** of this ordinance.
- 3.2 Learners who exit with a UG certificate or UG diploma shall be permitted to reenter within three years and complete the degree programme. Learners may be permitted to take a break from the study during the period of study but the total duration for completing the 4 years programme shall not exceed 7 years. The maximum total duration shall include the period of absence, withdrawal and

- different kinds of leave permissible to a learner but it shall exclude the period of rustication/suspension/or any other penalty period imposed by the University.
- 3.3 A learner after successful completion of the two, four, six and eight semesters of the programme shall be awarded Certificate, Diploma, Degree, Honours respectively in the field of study/discipline for which he/she was enrolled as per **Appendix-I** of this ordinance.
- **3.4** The learner having UG Certificate/UG Diploma are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of seven years.
- **3.5** Discipline/Field of study under which award will be given, shall be decided by the University through Regulation from time to time.

4. Eligibility for Admission:

- **4.1** Learner seeking admission to the first semester of the programme must have passed Higher Secondary (10+2) examination of C.G. Board of Secondary Education or any other Examination recognized by the University or C.G. Board of Secondary Education as equivalent thereto.
- **4.2** Eligibility for admission in a particular discipline will be as notified by the University/Chhattisgarh Govt. from time to time.
- **4.3** Learners who leave with a Certification, Diploma, or a Basic Bachelor's Degree will be eligible to re-enter the programme at the exit level to complete or progress to the next level.

5. Undergraduate Curriculum Framework (UGCF)

- **5.1** Courses/syllabus as per UGCF for Four Year Undergraduate Programme shall be prepared by incorporating the following points:
- **5.1.1** The courses shall be based on credit system.
- **5.1.2** Programmes offered shall consist Programme Outcome (PO) and Programme Specific Outcome (PSO) and each course of the programme shall consist Course Learning Outcome (CLO). PO, PSO and CLO. It shall be prepared in accordance with the Graduate Attributes determined by the UGC.
- **5.1.3** Syllabus shall also consist mapping of CLO to PO and PSO.
- **5.1.4** There shall be 5 level of courses based on the learning outcomes, level of difficulty and academic rig our and distributed across semesters in ascending order, viz,

- Level-1 (0-99), Level-2 (100-199), Level-3 (200-299), Level-4 (300-399) and Level-5 (400-499) corresponding to prerequisite, foundation or introductory, intermediate level, higher level, and advanced courses respectively.
- **5.1.5** Course content related to Indian Knowledge System (IKS) shall also be incorporated in syllabus.
- **5.2** UG Degree Programme shall be of the following categories:
- **5.2.1 UG Degree Programmes with Single Major**: A learner has to secure a minimum of 50% credits from the major discipline for the 3-year/4-year UG degree to be awarded a single major.
- **5.2.2 UG Degree Programmes with Double Major**: A learner has to secure a minimum of 40% credits from the second major discipline for the 3-year/4-year UG degree to be awarded a double major.
- **5.2.3 Interdisciplinary UG Programmes**: The credits for core courses shall be distributed among the constituent disciplines/subjects so as to get core competence in the interdisciplinary programme.
- **5.2.4 Multidisciplinary UG Programmes**: In the case of a learner pursuing a multidisciplinary programme of study, the credits of core courses will be distributed among the broad disciplines. For example, in case of multidisciplinary programme, a student may opt three disciplines, such as Physics, Mathematics, and Chemistry from the Faculty of Science or Zoology, Botany and Chemistry from the Faculty of Life Science. Similarly, in case of single discipline faculty, like B. Com. and B. H. Sc. etc. all the courses under this category shall be from same faculty.
- **5.3** Every multidisciplinary/single disciplinary programme shall offer following categories of courses of study:
- **5.3.1 "Discipline Specific Core" (DSC) Course:** DSC is a course of study, which shall be pursued by a learner as a mandatory requirement of his/her programme of study.
- **5.3.2 "Discipline Specific Elective" (DSE) Course:** The DSEs shall be credit courses from a pool of core discipline, from which a learner opts to study. It comprises a

list of elective courses for each discipline, from which learner may select any one discipline based on their interests and objectives.

5.3.3 "Generic Elective" (GE)/Multidisciplinary Course: GE shall be a pool of courses which is meant to provide multidisciplinary or interdisciplinary education to students. GEs shall consist of a pool of courses offered by various disciplines of study (excluding the GEs offered by the parent discipline), in groups of odd and even semesters, from which a student can choose. The GEs specified in the framework would be identified by the concerned Department as GEs to be taught in a Programme.

GE/Multidisciplinary courses are intended to broaden the intellectual experience and form part of liberal arts and science education. Learners are not allowed to choose or repeat courses already undergone at the higher secondary level (12th class) in the proposed major stream under this category.

- **Note:** A core course offered in a discipline/subject may be treated as an elective by other discipline/subject and vice versa and such electives may also be referred to as Generic Elective.
- 5.3.4 "Ability Enhancement course" (AEC): AEC courses consist of modern Indian language (MIL) and English language focused on language and communication skill. It aims at enabling the learner to acquire and demonstrate the core linguistics skills, including critical reading and expository and academic writing skills, that help learners articulate their arguments and present their thinking clearly and coherently and recognize the importance of language as a mediator and identity. The courses will also emphasize the development and enhancement of skills such as communication, and the ability to participate/conduct discussion and debates.
- **5.3.5 "Skill Enhancement Course" (SEC):** SEC courses are skill-based courses in all disciplines, aimed at providing practical skills, hands-on-training, soft skills etc., to enhance employability of the learner. SEC courses may be chosen from a pool of courses designed to provide skill-based instructions.
- **5.3.6 "Value Added Course" (VAC):** VAC courses are value based courses which are meant to inculcate the development of humanistic, ethical, constitutional, and universal human value of truth, righteous conduct, peace, love, nonviolence,

- scientific temper, citizenship values and life skills. It also includes environmental science/education.
- **5.3.7 "Internship"**: A course requiring students to participate in professional employment- related activity or work experience, or cooperative education activity with **preferably** an entity external to the education institution, normally under the supervision of an employee of the given external entity. A key aspect of the internship is induction into actual work situations. Internships involves working with local industry, businesses, artists, crafts persons, etc. and opportunities for students to actively engage with the practical side of their learning.
- **5.4 Number of Credits by types of courses:** The Undergraduate Curriculum Framework for Four Year Undergraduate Programme shall have courses as much as possible with credits as specified in **Appendix-II**. This shall be treated as sample table. The number of credits to each type of course may be as below:
- **5.4.1** Major/DSC, Minor/DSE, Multidisciplinary/GE: Shall be of 4 credits or as appropriate. An additional one or two credits may be allotted for practical.
- **5.4.2** Other courses: All course under, AEC, SEC VAC, community outreach, internship and apprenticeship shall be of 2 credits or as prescribed by Regulation.
- **5.4.3** The above distribution of credits is suggestive. The detailed structure of UGCF courses with credit shall be notified by the University through its Regulation from time to time.
- 5.5 Remote/Blended Learning Modes: Options will be made available for learners to earn credit by completing quality-assured remote learning modes, including Study ofWebs Active Learning for Young Aspiring Minds (SWAYAM): (www.swayam.gov.in) or other equivalent online educational platform approved/notified by the University from time to time. Learners may opt to earn credits from such courses up to 40% of the total credits offered in a particular programme in a semester, in these modes. The detailed method and modality, including transfer of credit and approval of list of courses, shall be notified by the University through its regulation from time to time in consonance with UGC (SWAYAM) Regulations amended from time to time.

6. Medium of Instructions:

The medium of instructions, in general, shall be Hindi or English except for

language courses. However, University may ascertain the medium of instruction and examination for a specific programme, and in such cases the medium of instruction shall be as notified by the University.

7. Examination and Assessment/Evaluation

- **7.1** The academic performance of a learner shall be evaluated in respect of the courses of study prescribed for each semester through evaluation. The evaluation of learners admitted in the programme shall be based on:
- i. Term End (Semester) Examinations TEE -70% marks of total marks and
- ii. Tutor Marked Assignment (Continuous Internal Assessment) **TMA** 30% marks of total marks.
- **7.2** There shall be no internal assessment for a field work/ Internship etc.
- **7.3** Pattern of question papers of end semester examination and structure of scheme of continuous internal assessments for each course shall be as notified by the University through Regulation.
- **7.4** The **TEE** shall be held at the end of each semester and the duration of each course of end semester examination (Theory and Practical) shall be of three hours for courses having more than two credits and two hours for courses having less or equal to two credits.
- 7.5 The minimum percentage of marks required to pass the programme in each semester shall be 40% in each course comprising marks obtained in Term End (Semester) Examination **TEE** and Tutor Marked Assignment (Continuous Internal Assessment) **TMA**.
- **7.6** A programme shall have a specified number of credits in each semester. The number of credits along with grade points that the learner has satisfactorily achieved shall measure the performance of the learner.
- **7.7** There shall be provision of grace marks to enable a learner to pass the examination as notified by the University through Regulation.
- **7.8** Semester examination results shall have the following categories:
- i. **Passed**, i.e., those who have passed in all courses of the semester examination.
- ii. **Promoted**, i.e., those who have earned minimum 50% credits in a particular year including both the semesters (Even and Odd) or those who have earned any number of credit in odd semester.

Detained, i.e., those who have not passed or promoted as per the above provisions will be detained. Such students have to appear in the examination of next academic session to earn required credits (excluding the credits already earned) as per the provisions of this Ordinance and only then he/she may continue the programme. However, the same shall be subject to the condition of maximum time limit set out for the completion of the programme.

7.9 However, learner of any semester, not applied for examination/applied but not appeared in examination/not appeared in examination due to any other reasons may appear in the examination of same semester in the next academic session only.

Further a learner is eligible for promotion into next higher semester subject to fulfilling of conditions mentioned above and only when he/she has appeared in end semester examination either partially or fully of current semester.

8. Promotion Rule:

- **8.1** A learner shall be promoted and may take admission in the 2nd semester immediately after the 1st semester end examination irrespective of any number of back papers.
- 8.2 A learner may take admission in the 3rd semester provisionally, immediately after the 2nd semester end examination and his/her admission shall be confirmed to the 3rd semester only if he/she has earned minimum 50% credits in both 1st and 2nd semesters.
- **8.3** A learner shall be promoted and may take admission in the 4th semester immediately after the 3rdsemester examination irrespective of any number of back papers in 3rdsemester.
- 8.4 A learner may take admission in the 5th semester provisionally, immediately after the 4thsemester examination and his/her admission shall be confirmed and he/she will be promoted to the 5th semester only if he/she has earned minimum 50% credits including both 3rd and 4th semesters and cleared all the papers of 1st and 2nd semesters.
- **8.5** A learner shall be promoted and may take admission in the 6th semester immediately after the 5th semester with any number of back papers.

- **8.6** Examinations of back papers of odd semesters shall be conducted along with odd semesters end examinations, similarly examinations of back papers of even semesters shall be conducted along with even semesters end examinations.
- **8.7** Further, a special examination of the 5th semester shall be conducted along with the 6th semester for those students who have cleared all the papers till 4th semester.
- **8.8** A special examination of the 6th semester shall be conducted after the declaration of end semester result, for those students having back papers only in the 6th semester.
- **8.9** A learner may take admission in the 7th semester (Fourth year of UG) only after clearing all the semesters up to the 6th semester.
- **8.10** A learner will be promoted and may take admission in 8th semester (Fourth year of UG) provisionally, immediately after the 7th semester examination irrespective of number of back papers in the 7th semester.
- **8.11** A special examination of the 7th semester shall be conducted for students having back papers of 7th semester along with the 8th semester end examination.
- **8.12** A special examination of the 8th semester shall be conducted soon after declaration of the semester results. Any student having back papers in 8th semester shall be eligible to appear in this special examination.
- **8.13** A learner who secure 75% marks or above or equivalent 7.5 CGPA in the first six semesters, may choose honours course in the fourth year before the commencement of the fourth year by applying for the same, in a manner laid down for the same. However, pursuance of the course shall be subject to availability of seats and other criteria and shall be confirmed by the HEI.
- **8.14** In case a learner is detained or not promoted to higher semester, he/she will be held up till the back papers are cleared for which he/she can take attempt in the next appropriate examination provided that the same is done within the maximum duration allowed for the programme. TMA marks of such learners will be carried forward for the corresponding course(s) in which he/she is appearing.
- **8.15** For counting 50% credits both theory as well as practical courses shall be considered and 0.5 credit shall be rounded up.

9. Results Preparation

A learner who has passed in all the courses of each I, II, III, IV, V, VI, VII and VIII

semesters with a CGPA at least 4.0 shall be declared as '**Passed**'. The division shall be awarded after successful completion of Bachelor degree of programme of study as per **Table of Appendix-I** according to the following criteria:

i. First Division with distinction: CGPA ≥ 7.50

ii. First Division: CGPA \geq 6.00, but < 7.50

iii. Second Division: CGPA ≥ 4.50 but < 6.00

iv. Third Division: CGPA ≥ 4.00 but < 4.50

10. Computation of SGPA, CGPA and Format of Transcript/Marksheet

- **10.1** The SGPA and CGPA shall be calculated as per the formulae provided in the **Appendix-III.**
- Table of **Appendix III**, the transcript shall be issued as per the template shown in the **Appendix IV** or as per the template offered by Digi locker including the marks obtained, grade points, SGPA and CGPA along with other particulars of the learner, as the case may be HEI shall issue the transcript or mark sheet for each semester and a consolidated transcript indicating the performance in all the semesters. The details of the letter grade and formulae of SGPA and CGPA shall be given on the back side of transcript/mark sheet.

11. Conversion to Percentage

The conversion formula for converting the CGPA to the corresponding percentage (P)of marks will be as follows: **P=10xCGPA**

12. General:

- **12.1** There shall be no provision for repeat or improvement of the programme, once learner has cleared it.
- **12.2** Any points related to ABC and multiple entry and exit which are not covered in this Ordinance shall be dealt with as per the Regulation of the University in accordance with the provisions of UGC guidelines/Regulation issued from time to time.
- **12.3** Any points related to UGCF not covered under this Ordinance shall be as prescribed by the University through its Ordinance/regulation/guidelines from time to time.

12.4 If any question arises related to the matters not covered in this Ordinance, the relevant provisions made in the Act/appropriate Statutes/Ordinances of the University or the UGC shall be applicable.

13. Removal of Difficulties

If any difficulty arises in giving effect to the provisions of this Ordinance, the Kulapati may, by order, make such provisions not inconsistent with the Act, Statutes, Ordinances, or other Regulations, as appears to be necessary or expedient to remove the difficulty. Every order made under this rule shall be subject to ratification by the appropriate University authorities.

E-1.5: Bachelor of Computer Applications (BCA) (Under Section 27 (1) of the Chhattisgarh Act No. 26/2004)

The Bachelor of Computer Application (BCA) shall be instituted in the university under the Department of Computer Science and Application.

1. Objective:

The basic objective of the programme is to open a channel of admission for computing courses for learners, who have done the 10+2 and are interested in taking computing as a career. After acquiring the Bachelor's Degree (BCA) at PSSOU, Bilaspur, there is a further educational opportunity to go for an MCA or Master Degree programmes at PSSOU or other University.

2. Duration of Programme:

The duration of the programme for the BCA education programme shall be three academic year (as per academic calendar of the University).

3. Admission:

A person, who have obtained 10+2 certificate from the recognized board with Mathematics as one of the subject shall be eligible for admission to the BCA programme of the university.

A Candidate seeking admission to BCA I year and not having maths subject at 10+2 level shall be required to undergo preparatory programme in Math's (PPC) and study Math's paper at BCA II and BCA III year as well. However only the qualifying shall be required in these Course and marks will not be added in overall totals. These shall be purely a non-credit course. After completion of PPC, they would not get any certificate/grade card as it is not an independent programme. They will get only Intimation of the examination result.

4. Credit System:

The University follows the 'Credit System' for its Programme.

5. Mode of Instructional System:

The University tries to follows a multi-channel approach for instruction.

6. Contact Class:

There shall be contact programmes for theory and practical courses. The duration, centre, attendance, prior information, venue, date and time, etc. decided by the university time to time.

7. Counselling Session:

The University provides the facility at selected Study Centers or any other place decided by the university, during this session Counselors will not be delivering lectures as in conventional teaching. They will try to help learner to overcome difficulties of the learner during the study of computer application programme.

8. Medium of Instruction:

The medium of instruction is English/Hindi. The language of course material is depending on the availability of the self-Instruction Material/Text book. Learner may opt to write the answer in Hindi/English in Continuous evaluation examination/Term end examination.

9. Maximum period of programme:

The learner must pass the examination of BCA within six year of his/her admission academic session to the course. A learner failing in either or both of the continuous evaluation/term end examination/practical Course may reappear as a "Back-log" learner in the part concerned or in the whole as the case may be at a subsequent examination without being required to undergo regular course of studies again. Subject to his/her complying with the provisions of the ordinance and regulations. In this case pass course mark are carry forwarded. If learner fails to clear the programme within the above prescribed period must take the re-registration of the programme.

- **10. Examination**: As per provisions given in the ordinance.
- **11. Other provisions**: As per given in the ordinance.

E-1.6: <u>Bachelor of Library & Information Science (B.Lib. & I.Sc.)</u> (Under Section 27 (1) of the Chhattisgarh Act No. 26/2004)

1. Programme title: Bachelor of Library & Information Science/B.Lib. & I.Sc.

2. Objectives:

- a. To impart know of modern library practices with a view to develop basic expertise in modern library Management.
- b. To inculcate a sense of responsibility and awareness of professional belonging.
- c. To impart an understanding and an appreciation of the role of libraries in the society in order to words impart knowledge about their social purpose.

3. Duration of the Programme.

The duration of the programme shall be of 12 months. However, a learner registered once can complete the programme within a maximum period of three years.

4. Eligibility for Admission.

A Bachelor's Degree from any recognized University.

5. Admission Criteria

Admission is open to all who fulfill minimum academic qualification.

6. Medium of Structure

The medium of instruction shall be Hindi & English.

7. Programme Instruction.

The Programme shall consist of theory Course and 1 practical paper as prescribed by the related board of studies.

8. Scheme of Examination:

Examinations scheme will be as per provisions led down section C1 of this ordinance.

9. Eligibility for Examination:

A Candidate admitted to a programme can sit for the term-end examination only after completing the full academic year on the programme as well as the prescribed number of assignments, term Course etc. for it.

E-1.7: <u>Bachelor of Education (Open)/(B.Ed.)</u> (Under Section 27 (1) of the Chhattisgarh Act No. 26/2004)

1. **Programme title:** Bachelor of Education (Open)/B.Ed. (Open)

2. Programme Objective:

The program aims to achieve the following objectives.

- 1. To systematize experiences and strengthen the professional competency of in–service teachers.
- 2. To develop skills required in selecting and organizing learning, experiences.
- 3. To understand the nature of the learner and of learning processes.
- 4. To develop skills involved in dealing with the academic and personal problem of learners.
- 5. To acquire knowledge and develop understanding about the various procedures and techniques of evaluation and their classroom application.
- 6. To provide knowledge and develop understanding about various aspects of school management.
- 7. To develop an appreciation of the role of the teacher in the prevailing sociocultural and political in general and the educational system in particular.

3. Jurisdiction

Regulations 23 (3) of UGC (ODL Programmes and Online Programmes) Regulations, 2020 under heading Learner centric provisions stipulates as under: -

"(3) Learner's enrolment (for open and distance learning mode): A learner residing in any part of the Country may enrol in any program being offered by a Higher Educational Institution recognized by the Commission for offering programme under Open and Distance Learning mode provided that the Higher Educational Institution shall conduct all the activities such as admissions, contact programmes, examinations etc. for learners strictly within the territorial jurisdiction of the Higher Educational Institution as specified in this regulation…"

In Liew of the above provision of UGC ODL regulations -

- **A.** The University shall not discriminate against any candidate on grounds only of religion, race, caste, sex, place of birth or any of them. However, reservation policy of the State shall be strictly followed.
- **B.** Maximum number of outside state candidates shall be up to 20 percent of UR candidates. However, outside state candidates shall conduct all desired activities of the programme like counselling, contact classes, practical's, examinations etc. at the registered study centers of the state only. Candidates will have to fulfill all the programme requirement as per the university rules.

4. Duration

The duration of the programme is of 24 months excluding tine taken from admission subject to maximum period of four years.

5. Eligibility

As per NCTE Norms.

6. Admission Criteria

The University shall conduct an entrance examination. The selection shall be made on the ranking basis as per the merit list within the Purview of exciting reservation criteria. In the case of non-conduction of entrance examination due to unavoidable circumstances like COVID-19 pandemic, the admissions will be done on merit basis. Details of the procedure will be laid down by Academic Council.

7. Medium of Instruction

The medium of instruction shall be Hindi/English.

8. Programme Structure

As per decision of BOS.

9. Instruction System

- (a) The B.Ed. Programme shall be delivered through self-instructional print materials, audio-video programme, assignments which shall be provided by the University.
- (b) Candidates shall conduct Practice teaching and school-based activities in the schols situated in the state.

(c) Counseling, contact programmes and workshops shall be carried out in the teacher training institutes designated as programme Centers.

10. Eligibility for Examination

- (i) The teacher candidates who received lessons/assignments issued by university through correspondence and submit response sheets thereto, to the satisfaction of the heads of the concern programme centres of the university, in respect of all theory Course during the session, attend the practical training at the programme centre and complete teaching of prescribed number of lessons.
- (ii) The teacher candidates have to produce a certificate from the head of the programme centre to the effect that they fulfil all conditions for the purpose of being admitted to the examination including those as enumerated in item (i).

11. Examination Scheme

As per section C-1 of this Ordinance or will be decided by BOS.


