STATUTE NO. - 11 OTHER OFFICERS OF THE UNIVERSITY

Condition of Service, Powers and Duties (Refer Section 21)

1. In addition to the Officers mentioned in Section 21 of the Adhiniyam, the following shall be the Officers of the University –

(A) OFFICERS OF STATE UNIVERSITY SERVICES-

- 1. Deputy Registrar
- 2. Finance Officer (Deputation)
- 3. University Engineer (Deputation)
- 4. Controller University Press
- 5. Assistant Registrar

(B) OTHER OFFICERS -

- (i) Regional Director
- (ii) University Librarian
- (iii) Examination Controller
- (iv) Head of Computer Centre (System Engineer)
- (v) System Engineer
- (vi) Assistant Librarian
- (vii) Assistant Engineer
- (viiii) Computer Programmer
- (ix) Technical Assistant
- (x) Medical Health Officer.
- (xi) Assistant Regional Director
- (xii) System Analyst
- (xiii) Student Welfare Officer
- (xiv) Public Relation Officer
- (xv) Assistant Student Welfare Officer

- 2. The Scales of pay for the posts mentioned in paragraph (1) above shall be as under –

Pay Scale as announced by State Govt. From time to time.

Provided that where an officer serving under the Central Government or a State Government is on deputation to the University and is appointed as Finance Officer or University Engineer, his emoluments and terms and conditions of service shall be as laid down by the Government concerned while placing the service of the officer at the disposal of the University.

Provided further that for the appointment of a retired Govt. on University servant, the rule of CG. Govt. Contract service, 2004 shall be applicable and admissible to him.

2. The Qualification of the Officers appointed under paragraph 1(A) shall be the same as per the State University rules, 1983. For the appointment of Officers other than State University Services mentioned in paragraph 1(B) the Executive Council shall prescribe the qualifications. The prescribed qualifications shall be given due publicity and the Selection Committee shall select the candidates for such offices with due required to the qualifications prescribed.

- 3. The Executive Council shall appoint a Selection Committee consisting of the Kulpati who shall be the Chairman of the Selection Committee, one nominee of the Executive Council from amongst its members and one nominee of the Kuladhipati not connected with the University to recommend the names of candidates for appointment to the offices mentioned in paragraph 1(B). The Committee so constituted shall recommend not more than three and not less than two names for each post in order of merit and the Executive Council shall make appointment from the panel.
- 4. The Officers appointed under Paragraph 1(A) & (B) mentioned in the Statues shall be entitled to leave, leave salary, allowances, medical benefits, provident fund and other terms and conditions of service including the age of retirement shall be such may be prescribed by the State Govt. for the Officers under paragraph 1(A) and by the University for the Officers of paragraph 1(B) of the University. The University shall pay all benefits to the employee of Paragraph 1(A) & (B).

Provided that where an officer is a retired employee of the Central Government or any State Government he shall not be entitled to the benefit of contributory provident fund.

5. The Powers and duties of each Officer except the Finance Officer mentioned in this Statute shall be such as the Executive Council may determine.
